Peter Kellison of Clear Advocacy, LLC gave an update briefing on all the policy issues affecting Residential Care Facilities for the Elderly (RCFEs). Amber Cutler from National Senior Citizens Law Center presented on Cal MediConnect now that it has been in effect for a year. Tim Frazier, St. Paul's Chief Operating Officer, gave an overview on Assembly Bill 361 California Health Homes for Patients with Complex Needs, pointing out that the Program of All-Inclusive Care (PACE) already provides many of the services proposed in the bill.

St. Paul's, through a partnership with [BRIDGE Housing](#), is pleased to report that construction of 63 new apartments for [PACE](#) participants at the new Celadon development are on track for Spring 2015 completion.

St. Paul's [Program of All-Inclusive Care for the Elderly \(PACE\)](#) provides all-inclusive healthcare services to frail, low-income seniors to help them live successfully at home, rather than a nursing home.



[Celadon](#), currently under construction at 9th and Broadway in Downtown San Diego, will feature 250 affordable homes for individuals and small families. Of these studios and one-bedroom units, 88 are targeted for supportive housing, including St. Paul's 63 apartments, which will have a priority on placement for veterans.
