St. Paul's Senior Homes & Services was recently designated as a Jubilee Ministry Center for the Episcopal Diocese of San Diego. Currently there are over 450 Jubilee Ministry Centers in the Episcopal Church world wide. These centers are community-based sites that are dedicated to improving the lives of the poor through programs of outreach, evangelism, empowerment, and advocacy. Because those engaged in this ministry frequently need the type of assistance found only in programs that get to the root of community problems, much of St. Paul's Jubilee ministry work will be centered around the Program for All Inclusive Care of the Elderly (PACE).

## RESIDENT PROFILE COMPLETED AT ST. PAUL'S

A recent profile of current Residents was completed by the Marketing and Public Relations Department that offers some fun facts about the Residents that reside at St. Paul's Senior Homes & Services. Did you know...

That 23% of the Residents at the Manor are Episcopalian, 17% are Catholic and 11% are Presbyterian, 6% are Jewish and that 22% of the Residents at the Villa are Catholic, 12% are Episcopalian, 11% are Presbyterian and 7% are Jewish?

That 71% of Manor Residents and 52% of Villa Residents listed "location" as among the primary reasons for choosing St. Paul's?

That Residents of the Manor represent 67 different previous occupations and Residents of the Villa represent 83 different previous occupations including Deep Sea Diver, Weapons System Planner and Stockbroker?


That 68% of Manor Residents and 61% of Villa Residents heard about St. Paul's through family members, friends or their church?

That 87% of Manor and 66% of Villa Residents consider their health to be either "good," "very good," or "excellent?"

## RESIDENTS GIVE ST. PAUL'S HIGH MARKS

Recently, a Quality Assurance Evaluation (QAE) survey was made available to Residents at both the Manor and the Villa. The survey asked various questions of the Residents, based on five categories of service at St. Paul's Manor and Villa. These five categories of service included **reception desk, food service, housekeeping, maintenance, and resident services**. Each questionnaire item was based on a five point scale: "1" representing lowest level of satisfaction to "5" denoting the highest satisfaction. There was also space on the survey for written comments. The results of the survey are shown below:

## GENEROSITY FOR GENERATIONS-A PLACE FOR PACE

This campaign theme has been selected for the St. Paul's \$3 million capital campaign. The campaign will raise the funds to purchase additional property to house an affordable housing complex, a pre-PACE Adult Day Health Care Center, and later a Program of All-inclusive Care for the Elderly (PACE).

The housing needs for San Diego seniors over the age of 80 are at a critical stage. Downtown development has displaced literally hundreds of seniors from their affordable housing. In the three contiguous zip codes-including St. Paul's- there are more than 8,000 seniors over the age of 80, and more than 27% of those are disadvantaged seniors.

Along with housing needs these seniors have greater health care needs requiring diverse resources, which are utilized at a much higher rate than other any other group in society.

Because of the trust and confidence in St. Paul's combined with a commitment to the establishment of a PACE program, an anonymous donor has pledged \$1 million towards this project, conditional upon our raising the other \$2 million in cash and pledges. With your help, and the help of others, St. Paul's will be able to provide significant new services to elderly seniors in San Diego. We cannot realize this vision without you and your **Generosity for Generations** of future senior.
