Mike Leavitt, Cabinet Secretary for Health & Human Services, paid a visit to St. Paul's Manor in May to encourage the residents to sign up for Medicare Part D before the May 15th deadline. The Secretary stopped at every table in the dining room during his dinnertime visit to personally greet each resident.

"I know there have been many questions related to the new Medicare Prescription Drug Plan, so I encourage you to do three things," Leavitt said. "First, place all your prescription drugs on your table, then take out your Medicare card and finally make a call to 1-800-Medicare. It will only take thirty minutes for you to be personally guided to the best plan for your particular needs."

Cheryl Wilson, CEO for St. Paul's Senior Homes & Services, remarked that we were honored to host Secretary Leavitt during his tour through California. The residents appreciated his candid answers to their questions and were thrilled that a Cabinet Secretary would take the time to visit St. Paul's.

St. Paul's bids goodbye to two beloved Board Members, the Rev Tally Jarrett and Philip del Campo, PhD



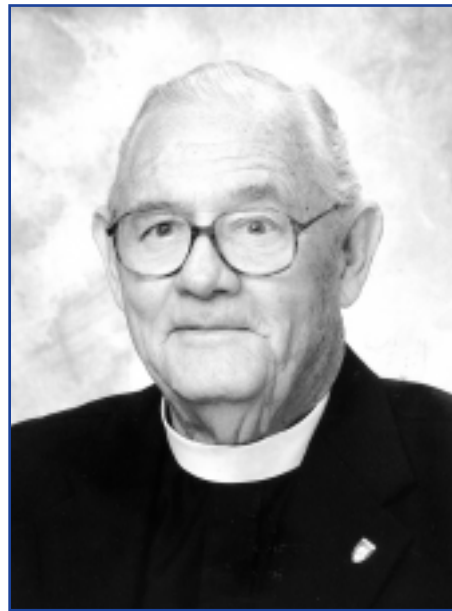

Dr. del Campo has been a member of the Board of Directors since March 2001 and was currently serving his second term.

Known for his great sense of humor and jovial personality, Dr. del Campo's presence demanded attention. For the past five years, Dr. del Campo has focused his attention to supporting St. Paul's mission to be the most outstanding and innovative senior homes and services provider in California.

Dr. del Campo is survived by his daughter, Lisa Ciota of Temecula; son, Greg del Campo of Temecula; sister, Alyce Temple of San Gabriel; two grandsons; and a great-grandson. He will be missed by all who knew him and his dedication to support the needs of the San Diego elderly community lives on forever.

The Rev. Tally Jarrett Jr. most recently served as church rector for St. Peter's Episcopal Church in Del Mar.



During Rev. Jarrett's career he served in both the Navy and the Air Force Reserves. He earned a bachelor's degree in medieval history from the University of Minnesota and a master's of divinity at Seabury-Western Theological Seminary in Evanston, Ill. He was ordained into the Episcopal priesthood in 1949.

Before deciding to become a pastor as a young adult, the Rev. Jarrett considered a career in medicine. "I had always wanted to do something with people," he told *The Union Tribune* upon his retirement. "And that's what this is - just like being a schoolteacher, a social worker or a psychologist."

The Rev. Jarrett is survived by his wife Lillian; daughter, Elizabeth Haines of Garden Valley; son, Paul Jarrett of Las Vegas; and three grandchildren.
